Funding is immediately available to -

Providers who have achieved an overall rating of 'outstanding' or 'good' in their most recent Ofsted Inspection

New providers registered with Ofsted until their first full Ofsted inspection judgement is published

The Local Authority will only fund eligible two year old children attending providers judged less than 'good' where there is not sufficient accessible outstanding or good provision and where it is in the best interest of the child for them to remain in the setting. This will be at the Local Authority's discretion. Where judged less than 'good' providers will work with the Local Authority to ensure the necessary improvements are made in a timely manner.

All providers judged less than 'good', and approved to offer the entitlement to parents/carers will be reviewed termly by the Early Years Funding Panel.

If you are a provider judged less than 'good' by Ofsted, and have not been approved to offer the entitlement as at 31st August 2016 and wish to do so in future, please complete and submit an Expression of Interest Form (Form 4) for consideration by the Early Years Funding Panel.
